NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in the First Ward of the City of Greenville, and on the West side of Pinckney Street, described as follows:

"BEGINNING at a stake on the West side of Pinckney Street at the corner of the lot belonging to the Central Baptist Church and running thence S. $39\frac{1}{2}$ W. with said Church lot, 140 feet to a stake; thence S. $41\frac{1}{4}$ E. 71 feet to a stake; thence N. $39\frac{1}{2}$ E. 151 feet to Pinckney Street; thence N. $50\frac{1}{2}$ W. with said Street, 68 1/3 feet to the beginning corner, and being a portion of W. P. McBee's homeplace and known as lot No. 22 as shown on plat made by J. N. Southern, D. S., on the 16th day of May, 1902, recorded in Plat Book "A" at Page 83, R. M. C.
