

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, and being known and designated as Lots Nos. 71 and 72 on plat of property of Paramount Park, recorded in the office of the Register of Mesne Conveyance for Greenville County in Plat Book W, page 57, and being more particularly described as follows:

LOT NO. 71: BEGINNING at an iron pin on the southeast side of Crosby Circle, joint front corners of Lots 70 and 71, and running thence along the joint line of said lots, S. 47-47 E. 168.1 feet to a point in the center of a 10-foot utility easement, with an unnamed creek as the line, joint rear corner of Lots 70 and 71; thence running along the meanders of said creek, which line is the joint rear lines of Lots 71 and 109 and a portion of 108, S. 63-20 W. 86.9 feet to a point, joint rear corner of Lots 71 and 72; thence along the joint line of said lots, N. 43-15 W. 145.3 feet to a point on Crosby Circle, joint front corners of Lots 71 and 72; thence turning and running along Crosby Circle, N. 46-45 E. 70 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty."

LOT NO. 72: BEGINNING at an iron pin on the southeast side of Crosby Circle, joint front corners of Lots 71 and 72, and running thence along the joint line of said lots, S. 43-15 E. 145.3 feet to a point on an unnamed creek, joint rear corner of Lots 71 and 72; thence running along the meanders of said creek as the line, which line is the joint rear lines of Lots 72 and portions of 107 and 108, S. 54-45 W. 91.1 feet to a point, joint rear corner of Lots 72 and 73; thence along the joint line of said lots, N. 43-15 W. 132.6 feet to a point on Crosby Circle, joint front corner of Lots 72 and 73; thence turning and running along Crosby Circle, N. 46-45 E. 90 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being two of the lots conveyed to me by Paramount Park, Inc. by deed of even date herewith, not yet recorded."
