"BEGINNING at an iron pin on the eastern side of the right-of-way of Augusta Road, joint front corners Lots Nos. 47 and 48, and running thence with the joint lines of said lots, S. 67-30 E. 100 feet to an iron pin at the rear corner of Lot No. 46; thence with the rear line of Lot No. 46, S. 4-57 E. 86 feet to an iron pin, joint rear corners Lots Nos. 48 and 49; thence with the joint lines of said lots, N. 69-0 W. 140 feet to an iron pin on the eastern side of the right-of-way of Augusta Road; thence with said right-of-way, N. 22-41 E. 80 feet to the beginning corner, including the plumbing, heating and electrical fixtures now located on said premises, or to be installed the reon, which are hereby expressly agreed to be a part of the realty.
