IN WITNESS WHEREOF, I, the undersigned, do hereby subscribe my name to the instrument of record in the office of the Clerk of Court of [REDACTED] and County of [REDACTED] as follows:

WHEREAS; I, Major Redmond Ramsey, do hereby make and give unto the Canal Insurance Company, a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagor, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, to the sum of Eighty Thousand Three Hundred Dollars (\$80,000.00), with interest from date at the rate of four & one-half percent (4 1/2%) per annum until paid, said principal and interest being payable at the office of Canal Insurance Company in Greenville, S. C., or some other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-six and fourteen one-hundredths Dollars (\$46.14), commencing on the first day of March 1955, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of February 1980.

Now, Know All Men, That in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagor, and in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, the Mortgagor has assigned, and released, and by these presents does grant, bargain, sell, assign, and convey unto the Mortgagor, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina:

All those certain pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 55, 56 and a portion of lot No. 61, as shown on plat of City View Annex recorded in plat book G pages 152-155 of the R. M. C. Plat Book, Greenville County, and having according to a survey made by R. W. Barton, January 1955, the following metes and bounds:

Beginning at an iron pin on the southwestern side of Craine Avenue, the front joint corner of lots Nos. 55 and 59, and running thence with the joint line of said lots S. 46-0 W. 167 feet to an iron pin in line of lot No. 56 thence with the rear line of lots 74 and 61 N. 31-30 E. 189.1 feet to an iron pin; thence N. 46-0 E. 189.1 feet to an iron pin on the southwestern side of Craine Avenue; thence with the southwestern side of said Avenue S. 13-50 E. 55.6 feet to an iron pin; thence continuing with the southwestern side of said Avenue S. 25-0 S. 61-8 feet to the beginning corner.

The above and following described property, together with all the buildings, fixtures, hereditaments, and appurtenances thereto belonging, now or hereafter to be erected, attached, or annexed thereto, and profits therefrom (provided, however, that fixtures and appurtenances are entitled to the same rights, immunities, and profits until default hereunder); all fixtures and appurtenances being attached to or becoming a part of the building or buildings herein described and in addition thereto the following personalty, which are now or hereafter to be, fixtures and a part of the realty and are in possession of the Mortgagor:


