"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, about three miles from the City of Greenville, on the west side of the White Horse Road, as shown on plat of property of Ellie Stroud Johns, et al., made by C. C. Jones, Registered Engineer, August 30, 1951, recorded in Plat Book T, page 357, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of the White Horse Road, which point is S. 0-47 E. 88 feet from the Ware property, and running thence S. 78-35 W. 152.5 feet to an iron pin; thence S. 51-30 W. 87.8 feet to an iron pin; thence S. 23-00 W. 29.7 feet to an iron pin; thence N. 87-05 E. 234.6 feet to an iron pin on the west side of the White Horse Road; thence N. 2-25 W. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same property conveyed to me by Ellie Stroud Johns by deed dated September 11, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 442, at page 22."
