NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of 'and, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the west side of the Suber Road, containing One (1) Acre, more or less, and being a part of Tract No. 3 of the W.H. Suber Property, plat by J. Earle Freeman, Surveyor, dated April, 1927, and having the following courses and distances, to wit: Beginning on a nail and stopper in the center of the Suber Road, on line of Tracts Nos. 2 and 3, and running thence with said line, 5. 80.40 W. 19 feet to iron pin on west bank of road; thence same course, 210 feet to an iron pin on said line; thence a new line, 5. 6.30 E. 210 feet to an iron pin; thence N. 80.40 E. 210 feet to a nail and stopper in the center of said road (iron pin back on line at 19 feet); thence with the center of said road, N. 6.30 N. 210 feet to the beginning corner.
