NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Laurens Road (U. S. Highway No. 276) about 5 miles Southeast of the City of Greenville in Butler Township, and having according to survey made by M. W. Hall & Company September, 1948, the following metes and bounds to-wit:

"BEGINNING at an iron pin on the Southwestern edge of the right-Of-way of Laurens Road, said pin being where the Southwestern edge of the right-of-way of Laurens Road intersects with the Southeastern side of a 30 foot unnamed Road, and mnning thence along the Southeastern side of said unnamed road S. 38-39 W. 797.2 feet to iron pin; thence S. 56-59 E. 207.7 feet to iron pih; thence N. 38-39 E. 733.7 feet to iron pin on the Southwestern side of Laurens Road; thence along Southwestern side of said Laurens Road N. 39-45 W. 210.6 feet to the beginning corner, containing 3.6 acres."
