WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation  
organized and existing under the laws of South Carolina , hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Sixty-Four Hundred and no/100  
Dollars (\$ 6,400.00 ), with interest from date at the rate of four and one-half per centum  
( 4½ %) per annum until paid, said principal and interest being payable at the office of C. Douglas  
Wilson & Co. in Greenville, S. C.  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Thirty-Five and 58/100 Dollars (\$ 35.58 ),

if not sooner paid, shall be due and payable on the first day of January , 19 80 .

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville ,  
State of South Carolina :

All that certain piece, parcel or lot of land, with the buildings and improve-  
ments thereon, lying and being on the Northerly side of Prancer Avenue, in the City  
of Greenville, S. C., and being shown as Lot No. 275 on the plat of Pleasant Valley  
and recorded in the RMC Office for Greenville County, S. C. in Plat Book P, page 92,  
said lot fronting 60 feet on the Northerly side of Prancer Avenue and having a depth  
of 160 feet on the Easterly side, a depth of 160 feet on the Westerly side, and being  
60 feet across the rear.
