per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Townshin, on the southern side of Old Anderson Road and being shown and designated as Lot 2 on the plat of J. R. Stephens property recorded in Plat Book "L" at Page 73, and described by the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Old Anderson Road at the corner of Lots 2 and 3 and running thence along the Old Anderson Road N. 51 E. 70 feet to an iron pin corner of Lot 1; thence with the line of Lot 1 S. 22% E. 200 feet to an iron pin in line of Lot 4; thence along the line of Lot 4 S. 51 W. 70 feet to pin at corner of Lot 3; thence with the line of Lot 3 N. 22% W. 200 feet to the point of beginning."
