C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, School District 315, near Berry's Mill, on the Northern side of the O'Neal-Berry's Mill Road, being bounded (now or formerly) on the Northeast by B. C. Berry, South and Southwest (now or formerly) by A. L. Southern, and Northwest by said road, and having the following courses and distances, to wit:-

FEGINNING on a nail and stopper in center of said road, joint corner of B. C.
