All that lot of land in Greenville County near Welcome Road on a 30 foot County Road known and designated as Lot No. 5 of the property of J. E. Strickland according to a plat thereof made by J. C. Hill dated August 6, 1954, and having, according to said plat, the following metes and bounds:
