WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand Five Hundred and No/100 - - - DOLLARS (\$ 12.500.00

DOLLARS (\$ 12,500.00), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the eastern portion of Lot 6 as shown on a plat of property of L. A. Mills recorded in Plat Book "Z" at Page 47, and also Plat Book "FF" at Page 255, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the western side of the Davidson Road joint front corner of Lots 6 and 7 and running thence with said road S. 23-12 W. 210.3 feet to an iron pin corner of Lot 5; thence with the line of said lot N. 79-00 W. 130 feet more or less to a point in the center of the East Poor House branch; thence up the meanders of said branch in a northerly direction 197.2 feet more or less to an iron pin on the joint line of Lots 6 and 7; thence with the joint line of said lots S. 82-41 E. 190 feet more or less to the point of beginning."

Being the same premises conveyed to the mortgagor by deed of Lois I. Holcombe recorded in Deed Book 516 at Page 80.

It is the intention of the mortgagor to include in this mortgage the easement for water and sewer lines extending to North Parker Road more fully set out in the deed above referred to.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
