TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Virginia E. Byers (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto A. C. Ashford

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand and No/100 - -

DOLLARS (\$ 1000.00),

with interest thereon from date at the rate of two (2%) per centum per annum, said principal and interest to be repaid: PAYABLE: On or before one year after date with interest thereon from date at the rate of two (2%) per cent. per annum, to be computed and paid at maturity.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, being known and designated as Lot 77, as shown on a plat of Dixie Heights, recorded in Plat Book H at Page 46, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the southeast side of Dixie Avenue which pin is 300 feet northeast from the intersection of Dixie Avenue and Lowndes Hill Road, and is the joint front corner of Lots Nos. 77 and 78, and running thence with the joint line of said lots S. 46-48 E. 150 feet to an iron pin in line of Lot No. 86; thence with the line of said lot N. 43-12 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 76 and 77; thence with the joint line of said lots N. 46-48 W. 150 feet to an iron pin on Dixie Avenue; thence with said avenue S. 43-12 W. 50 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by A. C. Ashford and Vera Elair Ashford by deed to be recorded herewith.

It is understood and agreed that this mortgage is junior in lien to a mortgage executed by the mortgagee to Fidelity Federal Savings & Loan Association in the sum of \$3200.00, of even date.

Together with all and singular the rights, tenements, and appurtenances to the same belonging or in any way incident or appertaining, and all of the uses, tenures, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fixed thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment other than the usual household furniture, be considered a part of the real estate.
