NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 3 of Section I of Oak Crest, lying on the southern side of Welcome Avenue, and having, according to plat made by C. C. Jones, the following metes and bounds:

"BEGINNING at a pin on the south side of Welcome Avenue at the corner of Lot No. 2, which pin is 135 feet from the northwestern corner of said subdivision, and running thence with Welcome Avenue, N. 60-02 E., 70 feet to a pin at corner of Lot No. 4; thence with Lot No. 4, S. 29-58 E., 150 feet to a pin, corner of Lot No. 34; thence with line of Lot No. 34, S. 60-02 W., 70 feet to a pin, corner of Lot No. 2; thence with line of Lot No. 2, N. 29-58 W., 150 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same property conveyed to me by Brown, Inc. by deed dated March 3, 1955, not yet recorded."

This is a construction mortgage. A lapse of a period of more than 30 days without any construction work being done thereon, or a failure to complete the house within a reasonable time, not to exceed six months, shall constitute a breach of the terms of this mortgage and the holder hereof may institute foreclosure proceedings without delay.
