ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property to wit: following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the southern side of the Old Easley Bridge Road, and being a portion of Lots Nos. 126 and 127 of Camilla Park, Plat No. 4, as shown on a plat thereof being recorded in the R. M. C. office for Greenville County in Plat Book M, at page 117, and having, according to a more recent plat prepared for Elmer Lyda by J. C. Hill, L. S., January 5, 1952, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of the Old Easley Bridge Road, which pin is 74.7 feet northeast of the intersection of the Old Easley Bridge Road and Cole Road, and running thence S. 6-05 E. 96.4 feet to an iron pin; thence S. 89-09 E. 70 feet to an iron pin; thence N. 10-50 W. 139.7 feet to an iron pin on the southern side of the Old Easley Bridge Road, which point is 102.7 feet southwest of the front corner of Lot No. 128; thence S. 54-23 W. 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to me by Carrie Lyda and Elmer Lyda by deed not yet recorded."

This is a construction mortgage. A lapse of a period of more than 30 days without any construction work being done thereon, or a failure to complete the house within a reasonable time, not to exceed six months, shall constitute a breach of the terms of this mortgage and the holder hereof may institute foreclosure proceedings without
