NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the Southern side of Drummond Court and Maggie Street, near the City of Greenville, being shown as Lot No. 12 on a plat of Fairfield Place, recorded in Plat Book BB at Page 141, and described as follows:

BEGINNING at a stake at the Southern corner of Drummond Court, and running thence with the Southwestern side of Maggie Street S. 36-10 E. 80 feet to a stake at corner of Lot 10; thence with the line of said lot S. 53-50 W. 160 feet to a stake in line of Lot 21; thence with the line of said lot N. 40-34 W. 64.9 feet to a stake on Drummond Court; thence with the curve of Drummond Court, the chords of which are N. 35-23 E. 75 feet, and N. 47-41 E. 75 feet to a stake at the corner of Maggie Street; thence with the curve of the intersection, the chord of which is S. 83-40 E. 27 feet, to the beginning corner.
