The mortgagor agrees that there shall be added to each monthly payment required hereunder, or under the evidence of debt secured hereby, an amount estimated by the mortgagee, to be sufficient to enable the mortgagee to pay, as they become due, all taxes, assessments and similar charges upon the premises subject thereto; any deficiency, because of the insufficiency of such additional payments, shall be forthwith deposited by the mortgagor with the mortgagee upon demand by the mortgagee. Any default under this Paragraph shall be deemed a default in payment of taxes, assessments or similar charges required hereunder.
