WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Thousand and No/100- ----

DOLLARS (\$ 8000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

' WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot 37, of Section H, as shown on revised plat of Croftstone Acres, recorded in the R.M.C. Office for Greenville County in Flat Book Y at Page 91, and having according to said plat the following metes and bounds. to-wit:

"BEGINNING at an iron pin on the Northern side of Broughton Drive, at the joint front corne r of lots 37 and 37, and running thence along the common lines of said lots, N. 10-22 E. 188.5 feet to iron pin; thence S. 83-29 F. 114.7 feet to iron pin at corner of lot 38; thence with line of lot 38, S. 21-38 W. 206.5 feet to an ron pin on Broughton Drive; thence with the northern side of Broughton Drive, N. 75-03 W. 75 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Volume 513 at Page 251.
