ASSIGNMENT OF MORTGAGE  
(Assignment by United States, as Trustee)  
(South Carolina)

KNOW ALL MEN BY THESE PRESENTS That the United States of America, Trustee of the assets of the South Carolina Rural Rehabilitation Corporation, which assets were transferred to the United States pursuant to Section 2(f) of the Rural Rehabilitation Corporation Trust Liquidation Act (54 Stat. 98; 40 U.S.C. 440), herein called "Assignor", the holder of a certain mortgage dated February 12, 1954, made by Joe B. Green and Annie Sue Green, his wife, recorded in Mortgage Book No. 587, at Page No. 173, in the Office of Clerk of Court, County of Greenville, State of South Carolina, and given to secure payment of a promissory note executed by the makers of said mortgage, dated February 12, 1954, for the principal sum of Six Thousand Nine Hundred Fifty and no/100 Dollars (\$ 6,950.00), with interest at the rate of three percent (3%) per annum, in consideration of one dollar and other valuable consideration in hand paid by The South Carolina Rural Rehabilitation Corporation, a corporation organized and existing under the laws of South Carolina, of Rock Hill County of York, State of South Carolina, herein called "Assignee", the receipt whereof is hereby acknowledged, does hereby assign, transfer, convey and set over unto the Assignee the said mortgage together with the said promissory note and claim secured thereby, before maturity and prior to default, to have and to hold the same unto the Assignee, its successors and assigns; and the Assignor does hereby make, constitute and appoint the Assignee its true and lawful attorney, irrevocable, in the name of the Assignor or otherwise, but at the proper costs and charges of the Assignee, to have, use and take all lawful ways and means for the recovery of the said money and interest, and in case of payment, to discharge the same as fully as the Assignor might or could do if these presents were not made.

THIS ASSIGNMENT shall be effective as of February 23, 19 55.
