TO ALL WHOM THESE PRESENTS MAY CONCERN: I, T. E. DeMINT,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWELVE THOUSAND SIX HUNDRED AND NO/100 - - - - - DOLLARS (\$ 12,600.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Briarwood Boulevard in the County of Greenville, State of South Carolina, and designated as Lot No. 38 on plat of Wildair Estates recorded in the R. M. C. Office for Greenville County, in Plat Book EE at Page 19 and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Western side of Briarwood Boulevard the joint front corner of Lots Nos. 38 and 39, and running thence along the joint line of said lots S 81-59 W 177.6 feet to an iron pin; thence N 10-42 W 100.12 feet to an iron pin at the joint rear corner of Lots Nos. 38 and 37; thence along the joint corner of said lots N 81-59 E 182.2 feet to an iron pin on the Western side of Briarwood Boulevard; thence along the Western side of said street S 8-01 E to an iron pin, the point of beginning.
