SEND GREETING:

Whereas, I, Hazel E. Seawright Hill, the said Hazel E. Seawright Hill, in and by my certain promissory note in writing, of even date with these Presents, I am well and truly indebted to Bank of Piedmont in the full and just sum of (\$773.32) Seven Hundred Seventy-three and 32/100, to be paid Payable one year from date
