"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, about two miles northwest of the City of Greer and on the North side of a road that leads from E.R. Taylor's Packing Shed to the Mosteller Road, sometimes known as the Ballenger Road, and being a part of Tract No. 1 of the Dantzler Ballenger Estate, plat prepared by H.S. Brockman, Surveyor, dated May 16, 1916, and having the following courses and distances: BEGINNING at a point in the center of said read(iron pin on North bank thereof at 10 feet from true center), corner with lands formerly owned by Billy Davis, and runs thence with said road S. 84 E. 208.6 feet to a point in said road(iron pin on North bank at 23 feet .from true center); thence N. 0.45 W. 210.8 feet to an iron pin; thence N. 84 W. 208.6 feet to an iron pin on the Billy Davis tract line; thence with line of the old Davis property S. 0.45 E. 210.8 feet to the beginning corner, and being all of that tract of land conveyed to the mortgagor by John W.
