WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100- - - - - -

DOLLARS (\$ 10,000.00) , with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot # 66, Section I of Lake Forest, recorded in the R.M.C. Office for Greenville County in Plat Book GG at Page 17, and described as follows:

"BEGINNING at an iron pin on the Eastern side of Lake Fairfield Drive, at the joint front corner of lots 66 and 67, and running thence with line of lot 67, N. 86-30 E. 151 feet to iron pin; thence N. 1-06 E. 56 feet to iron pin, joint rear corner of lots 65 and 66; thence with line of lot 65, N. 55-46 W. 142 feet to iron pin on Lake Fairfield Drive; thence with Lake Fairfield Drive, S. 18-37 W. 75 feet to iron pin; thence continuing with said Drive, S. 7-51 W. 75 feet to the beginning corner."
