WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixty-five Hundred and No/100 - -

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: 365.00 per month beginning July 15, 1955, and a like payment of 365.00 per . month on the 15th day of each month thereafter until paid in full, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed semi-annually and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his beirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the western side of Welcome Road near the City of Greenville, being the major portion of Lot No. 18 as shown on plat of property of J. Rowley Yown recorded in Plat Book "H" at Page 49, and described as follows:

"BEGINNING at a stake in Welcome Road 340.7 feet north from Anderson Poad and running thence with the said Welcome Road N. 32-20 W. 198 feet to a stake at corner of Lot 17; thence with the line of said lot S. 60-12 W. 512.3 feet to a stake at corner of Lot 20; thence with the line of said lot S. 28-05 E. 281.2 feet to a stake at corner of Lot 23; thence with the line of Lots 23 and 22 N. 61-55 $\rm E_{\bullet}$ 336.2 feet to a stake; thence N. 32-20 W. 100 feet to a stake; thence W. 61-55 E. 200 feet to the beginning corner."

Being the same property conveyed to the mortgagor by W. T. and Murell Y. Giles by deed recorded in Deed Book 513 at Page 272.

ALSO: All that lot of land in Gantt Township, Greenville County, State of South Carolina, on the western side of Mayflower Avenue near the city of Greenville, being shown as Lot No. 63 on plat of Pecan Terrace recorded in Plat Book "GG" at Page 9, and described as follows:

"BEGINNING at a stake on the western side of Mayflower Avenue at corner of Lot 64 and running thence with the line of said lot N. 72-27 W. 180 feet to a stake at corner of Lot 57; thence with the lines of Lots 57 and 58 S. 2-21 E. 74.5 feet to a stake at corner of Lot 62; thence with the line of said lot N. 72-27 E. 154.7 feet to a stake on Mayflower Avenue; thence with the western side of said avenue N. 17-33 E. 70 feet to the beginning corner.

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 504 at Page 202.
