All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Glenn Road in the City of Green-ville, County of Greenville, State of South Carolina, and being a portion of Lot 24, Section A of Glenn Farms as shown on a plat by H. S. Brockman, dated August, 1943, and recorded in the R. M. C. Office for Greenville County in Plat Book M at page 75, and as shown on a more recent plat entitled "Revised Map Lot 24 and Portion Lot 23 at Glenn Farms, Property of Mrs. Leonard Howard, Greenville, South Carolina," made by C.
