NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of U. S. Highway No. 29, and lying between U. S. Highway 29, and the Old Grove Road, and having according to plat of the property of Walter B. Meaders made by W. J. Riddle April, 1951, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of U. S. Highway No. 29, at the Southwest corner of tract of land owned by Walter B. Meaders and running thence with the Eastern side of right-of-way of U. S. Highway No. 29, N. 25-07 E. 342.5 feet to an iron pin; thence S. 79-52 E. 556 feet to an iron pin on the Eastern edge of Old Grove Road; thence with Old Grove Road as the line, S. 32-45 W. 229.7 feet to an iron pin in center of said road; thence N. 78-57 W. 251.5 feet to an iron pin at the rear corner of lot 1, as shown on plat of Grove Hills recorded in Plat Book P at Page 37, and running thence with the rear line of Lots 1 and 2, S. 32-15 W. 198.5 feet to an iron pin at rear corner of Lot 3; thence with line of Lot 3, N. 64-40 W. 240 feet to iron pin on the right-of-way of U. S. Highway No. 29, the point of beginning.

Chapman, on the East side of Grove Road, and running thence with the East side of Grove Road, S. 25-20 W. 100 feet to an iron pin; thence approximately S. 79-30 E. 530 feet, more or less, to an iron pin in the center of said Old Grove Road at a bend in said Road; thence with the center of said Old Grove Road N. 5-25 E. 100 feet to an iron pin at corner of other property of the mortgagor; thence along the line of other property of the mortgagor approximately N. 79-30 W. 500 feet, more or less, to an iron pin on the East side of Grove Road, the beginning corner.
