C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor s in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, School District 285, in the City of Greer, on the West side of Morrow Street, and being shown and designated as lots nos. 21, 22, and 23 on a plat of "Morrow Park", duly recorded in Plat Book E, page 91, R. M. C. Office for said County, and having the following courses and distances, to wit:-
