pating payment of the whole or any portion of the principal on any in-
terest payment date,

, with interest thereon from date

at the rate of Five per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due

corner of a lot nor, or formerly, owned by Dora Fagan; thence with her
line in a southerly direction, 167 feet to joint corner of properties
