All that piece, parcel or lot of land in Oaklawn Townshi, Greenville County, State of South Carolina, just off the Augusta Read and on the north side of the Pelzur-Old Hundred oad, and bein part of the Vera R. illiamson home place. The lot nerein conveyed is designated as lot No. 3 on a plat made by J.A. Pickens, Surveyor, on May 23rd, 1950 which shows the following courses and distances to wit;
