Gus Kondros-----SEND GREETING:

Whereas, I, the said Gus Kondros  
in and by a certain Promissory----- note in writing, of even date with these  
Presents, I am well and truly indebted to H. T. Simpson  
in the full and just sum of Three Thousand and no/100 (\$3000.00) Dollars  
, to be paid May 21, 1956--in full.

, with interest thereon from date  
at the rate of 6% per centum per annum, to be computed and paid annually  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said H. T. Simpson, his Heirs and Assigns for ever.

All that piece, parcel or lot of land in Gantt Township, Greenville County State of South Carolina, containing 50-1/4 Acres, more or less, as shown on plat made by C. M. Furman, Jr. Engineer, dated January 16, 1923, recorded in the R.M.C. Office of Greenville County. In Plat Book "B" Page 121 and having the following metes and bounds to wit:

BEGINNING at a persimmon Tree in Line of Property now or Formerly of Boniface, and running thence S-11 W 16.80 Chains to a Stone: thence N.75-1/2 E 5.12 to a stake on road: thence along said Road 18 chains to the beginning corner, and this being the same property conveyed to me by Susie Dandy by Deed which is recorded in the R.M.C. Office of Greenville County, S. C. March 9th, 1946 in Book 288 Page 317.
