NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, near Barton's Chapel, containing 18.6 Acres, more or less, and having the following courses and distances, to wit:

Beginning at a point in a new road, corner of F.M. Wilbanks and Lowell Barnett, and running thence with the Barnett line, N. 3.15 E. 959.7 feet to an iron pin in black gum stump; thence S. 81.25 L. 494 feet to an iron axle, corner of W.W. Edwards' land; thence S. 44.15 E. 461 feet to an iron pin; thence a new line, S. 20.00 ... 665.7 feet to a point in the new county road (running eastward from Barton's Chapel to Berry's Mill Road); thence along said road, N. 86.10 W. 1104 feet to the beginning corner.
