

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Four Thousand. Five Hundred and No/100 - - - - -

"BEGINNING at an iron pin on the northeastern side of Texas avenue, joint front corner Lots Nos. 6 and 8, and running thence with the joint line of said lots, N. 71-00 E. 228.89 feet to an iron pin at the rear corner of Lot No. 7; thence with the rear line of Lot No. 7 in a southeasterly direction 80 feet to an iron pin in the rear line of Let No. 3; thence with the rear line of Lots Nos. 3, 4 and 5, S. 71-00 W. 220 feet to an iron pin on the northeastern side of Texas Avenue; thence with said avenue, N. 22-10 W. 80 feet to the beginning corner, and being the same property conveyed to us by Clyde LaCount, et al. by deed dated June 12, 1951 and recorded in the R.
