ate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 4 as shown on a plat entitled "Property of W. R. Cordell, near Greenville, S. C." dated May 5, 1950, prepared by Dalton & Neves, and being recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book X at page 177.
