We, J. Mack Woods and W. R. Woods

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, being shown and designated as Lot No. 18 of Block C on Flat of Glenn Farms recorded in the R.M.C. Office for Greenville County, S. C., in Flat Book M, at page 75, and having, according to said Flat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Glenn Road, joint front corner of Lots Nos. 18 and 19, and running thence with the line of Lot No. 19, N. 13-40 W. 172.5 feet to an iron pin at the rear corner of Lot No. 3; thence with the rear line of Lot No. 3, S. 76-20 W. 100 feet to an iron pin at corner of Lot No. 17; thence with the line of Lot No. 17, S. 13-40 E. 195 feet to an iron pin on Glenn Road; thence with the Northern side of Glenn Road, N. 63-13 E. 104.5 feet to the point of beginning.
