WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Six Thousand, Six Hundred and No/100 - - - - - - -

(\$ 6,600.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 27 of a subdivision known as Oak Crest, Section I, property of Brown, Inc., as shown on plat thereof prepared by C. C. Jones and Associates, Engineers, January, 1955 and recorded in the R. M. C. office for Greenville County in Plat Book GG, at pages 110 and 111, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwest side of Templewood Drive at the corner of Lot 26, and running thence along the northwest side of said Templewood Drive, S. 60-02 W. 70 feet to an iron pin at the corner of Lot 28; thence along the line of that lot, N. 29-58 W. 150 feet to an iron pin at the rear corner of said lot; thence along the rear line of Lot 10, N. 60-02 E. 70 feet to an iron pin at the rear corner of Lot 26; thence along the line of that lot, S. 29-58 E. 150 feet to the beginning corner; being a portion of the property conveyed to mortgagor corporation by George F. Townes, individually and as trustee by deed recorded in the R. M. C. office for Greenville County in Vol. 517, at page 25."
