property of E. W. Smith, made by W. A. Hester, April 2, 1941 and
having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the East side of Hall
Road at the joint front corner of Lds 4 and 5 and running thence with
the line of Lot 4, South 59-3/4 East 132 feet to an iron pin;
thence South 24 West 70 feet to iron pin at corner of Lot No. 6;
