NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville,

being known and designated as Lot No. 87 of Section 2, on Plat of Stone Lake Heights recorded in the R.M.C. Office for Greenville County in Plat Book W, at page 87 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Merimac Court, at the joint front corner of Lots Nos. 87 and 88, and running thence with the line of Lot No. 88, N. 81-39 W. 154.9 feet to an iron pin in line of Lot No. 103; thence with the line of Lots Nos. 103 and 104, N. 19-27 E. 213.4 feet to an iron pin on a 10-foot walkway; thence with said walkway, S. 30-52 E. 172.37 feet to an iron pin on Merimac Court; thence with said Court, the chord of which is S. 4-30 W. 75.8 feet, to the beginning corner.
