"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing two acres, more or less, adjoining lands of J. M. McCall, Jack McCall and Irvin Philpot, and described as follows:

BEGINNING at an iron pin in the Highway at Jack McCall's corner, and running thence N. 83 W. 6.32 chains to a stake; thence S. 9 E. 3.17 chains to a stake on branch; thence crossing the branch, S. 83 E. 6.32 chains to an iron pin; thence N. 9 W. 3.16 chains to center of Highway.
