

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being known and designated as Lot No. 37 as shown on a plat of the subdivision known as Alta Vista, according to plat recorded in the R. M. C. Office for Greenville County in Plat Book G, page 20, having the following metes and bounds,

Beginning at an iron pin on Fairview Avenue at the corner of lot No. 36, and thence running along the joint line S. 85-40 E. 175 feet to an iron pin; thence N. 4-15 E. 70 feet to an iron pin at the rear corner of lot No. 38; thence along the joint line N. 85-40 W. 175 feet to an iron pin on Fairview Avenue; thence along Fairview Avenue S. 4-15 W. 70 feet to the beginning corner.
