"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Paris Mountain Township, being situate on the Northeast side of U. S. Highway No. 25 (the Buncombe Road), about 7 miles North of Greenville, and having the following metes and bounds as shown on Plat by W. P. Morrow recorded in the R.M.C. Office for Greenville County in Plat Book FF, at page 15, and having the following metes and bounds, to-wit:
