MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Malcolm D. Bragg, of Greenville County,

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Three Thousand, Four Hundred and No/100 - - - -

(\$ 3,400.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note, (the terms of which are incorporated herein by reference) to be repaid in installments of

upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee apart thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, barfollowing described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the west side of road from Taylors by St. Mark Church and bounded by land of E. E. Baker and other land of C. B. Loftis with metes and bounds, to-wit:

"BEGINNING at a stake on west bank of road and running with Baker's line, S. 82-00 W. 440 feet to stake; thence N. 8-00 W. 110 feet to stake; thence N. 70-45 E. 399 feet to stake by small pine on bank of road; thence along road, S. 22-15 E. 194 feet to beginning and contains one and one-half acres, more or less; being the same conveyed to me by C. B. Loftis by deed dated October 10, 1947 and recorded in the R. M. C. office for Greenville County in Vol. 366, at page 491."
