MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Hoyt Dill, of Greenville County.

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Four Thousand, Six Hundred and No/100 - - - -

(\$\frac{4,600.00}{}\)) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note, (the terms of which are incorporated herein by reference) to be repaid in installments of _______

Thirty-Eight and 82/100 - - - - (\$ 38.82) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, lying on the south side of the Groce Meadow Road, being bounded on the north by the said road and lands of James Paris, on the east by lands of Jack Snipes, on the south and west by lands of J. B. Crain, and being the same lot of land conveyed to Samuel A. Few by deed from Monroe W. Hardin, June 5th, 1948 and recorded in the office of the R. M. C. for Greenville County in Deed Book 355 at page 117, and having the following courses and distances, to-wit:

"BEGINNING on an iron pin in the center of the said Groce's Meadow Road, and runs thence with the Jack Snipes line, S. 39-40 W. 150 feet to an iron pin; thence with the line of J. B. Crain, N. 44-20 W. 263.4 feet to an iron pin; thence with another line of J. B. Crain, N. 40-50 E. 150 feet to an iron pin in the center of the said road; thence with the center of the said road, S. 44-30 E. 262.8 feet to the beginning corner, and containing nine-tenths (0.9) of one acre, more or less; being the same conveyed to me by Samuel A. Few by deed dated February 3, 1949 and recorded in the R. M. C. office for Greenville County in Vol. 373, at page 57."

The last payment on this mortgage, if not sooner paid, will become due and payable 15 years after date.
