NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Saluda Township, West of the Tagaloo Road, about 12 miles North from Marietta and according to a survey made by J. C. Hill January 8, 1953, is described as follows:

*BEGINNING at an iron pin in a private road, 300 feet more or less Northwest from Tagaloo Road, at corner of property of Clyde Bridges, thence with the line of said property, S. 25 W. 104.3 feet to an iron pin; thence S. 6 E. 95.9 feet to an iron pin at corner of property of E.
