"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, and now within the corporate limits of the City of Greenville, being a portion of Lot No. 1 of the property of Mrs. Georgia M. Wooten according to a plat thereof prepared by Dalton & Neves, in June, 1941, and being known and designated as Lot No. 1 of the property of Mrs. Georgia M.
