NOW, KNOW ALL MEN BY THESE PRESENTS, That the said Mortgagor in consideration of the said debts and sums of money aforesaid and for the better securing the payment thereof and also to secure the payment of any other sums advanced to said Mortgagor under the terms and provisions of this Mortgage as hereinafter set forth together with interest thereon, to the said JEFFERSON STANDARD LIFE INSURANCE COMPANY according to the condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said JEFFERSON STANDARD LIFE INSURANCE COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said JEFFERSON STANDARD LIFE INSURANCE COMPANY,

its successors or assigns, the following described property situated in the County of Greenville State of South Carolina: All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 8 of the property of J.E. Strickland as shown on a plat made by J.C. BEGINNING at an iron pin 449.7 feet in a Southerly direction from the South-eastern corner of the intersection of Welcome Road and a 30-foot Road, joint front corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 9 S. 73-00 E. 171 feet to an iron pin, joint rear corner Lots Nos 8 and 9; thence S. 17-00 W. 70 feet to an iron pin, joint rear corner Lots Nos. 7 and 8; thence with the line of Lot No. 7 N. 73-00 W. 171 feet to an iron pin on the Eastern side of said 30-foot road; thence with the Eastern side of said 30-foot road N. 17-00 E. 70 feet to the point of beginning.
