"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located about two miles East of the city of Greenville and about one-half mile South from the U.S. Super Highway No. 29, lying on the East side of the Edwards Road, containing one(1) acre, more or less, and having situate thereon mortgagor's residence. Said lot has the following courses and distances: EEGINNING at a point in the Edwards Road, iron pin S.85.29 E. 10 feet from said point, and runs thence S. 85.29 E. 427.5 feet to a stake (which stake is N.85.29 W. 116 feet from old iron pin corner); thence N. 4.31 E. 71.6 feet to a stake; thence N. 73.50 W. 377 feet to a point in the Edwards Road (stake back on line at 6 feet); thence with said road S. 26.07 W. 156 feet to the beginning corner, being a portion of that property conveyed to me, the mortgagor, by John Bolt Culbertson by deed dated November 14, 1950, recorded in the R.M.C.
