NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, about eight miles southwest of the City of Greenville, on the south side of Highway No. 294 and on the north side of the Old Grove Road, containing one acre, more or less, and having according to survey made by Dalton and Neves, Engineers, in April 1940, the following metes and bounds:

"Beginning in the center of Highway No. 294 in line of Mitchell property, and running thence with line of said property S. 11-40 E. 140 feet, more or less, to iron pin in center of old Grove Road; thence with center of Old Grove Road C. 35-20 W. 301.7 feet to a stake in line of such property; thence with line of said property N. 11-40 W. 67 feet to center of Highway No. 294; thence with center of said Highway, in an easterly direction 300 feet to the beginning corner; being the same property conveyed to the mortgagor by P.
