NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, located in the Town of Simpsonville, on the South side of South Pliny Circle, known and designated as lot No. 30 of the subdivision known as League Estates, according to a plat made by W. J. Riddle, Surveyor in October 1941, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "K" at pages 111, and 112, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a pin at the North East corner of lot No. 31 on the south side of South Pliney Circle and running thence along the South side of said Circle N.66-30 E. 80 feet to corner of lot No. 29; thence with line of lot No. 29, S. 35-30 E. 148 feet to pin; thence S. 75 W. 65 feet to pin; thence S. 55-30 W. 55 feet to corner of lot No. 31; thence with line of Lot No. 31, N. 19 W. 147 feet to the beginning corner.
