MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Lorena L. Henson and Carlos Henson, of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eight Thousand, Seven Hundred Fifty and No/100 - -

(\$ 8,750.00 -) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, near Marietta, S. C., and being known and designated as Lot No. 9 of a subdivision known as Blue Ridge Heights Development as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the northwest intersection of Glenn Street and an unnamed 30-foot street, and running thence with the western side of Glenn Street, N. 7-30 E. 200 feet, more or less, to an iron pin at the intersection of Glenn Street and an unnamed street; thence with the southern side of said unnamed street, N. 88-10 E. 160 feet to an iron pin; thence continuing with the southern side of said unnamed street in an easterly direction 20 feet to an iron pin at the front corner of Lots Nos. 9 and 11; thence with the front line of said lots, S. 6-55 W. 226 feet to an iron pin on the northern side of unnamed 30-foot street; thence with the northern side of said street, N. 81-14 W. 180 feet to the beginning corner; and being the same conveyed to us by Sam L. Rudd and Jewell E. Brooks by deed of even date herewith, not yet recorded."

The last payment on this mortgage, if not sooner paid, will become due and payable 18 years after date.
