MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Morris F. Smith, of Greenville County,

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, Eight Hundred and No/100 - - - -

(\$ 7,800.00 ) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note, (the terms of which are incorporated herein by reference) to be repaid in installments of

Seventy-Eight and No/100 upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the southeastern side of Mayfair Drive, joint front corner of Lots 16 and 17, and running thence with the joint line of said lots, S. 60-48 E. 150 feet to an iron pin, rear corner of Lots 16, 17, 7 and 8; thence with the joint rear line of Lots 15 and 16 and 8 and 9, S. 29-12 W. 100 feet to an iron pin, joint rear corner of Lots 9, 10, 14 and 15; thence with the joint line of Lots 14 and 15, N. 60-48 W. 150 feet to an iron pin on Mayfair Drive; thence with Mayfair Drive, N. 29-12 E. 100 feet to the beginning corner; being the same conveyed to me by Callie C. Brasil by deed dated August 3, 1955 and recorded in the R. M. C. office for Greenville County in Vol. 531, at page 99."
